## Preschool Fee Schedule 2024-25

Preschool is billed at a monthly rate based on the schedule chosen for your child. All preschoolers attend class in the same classroom, but there are schedule options based on your child's age. All classes are full day classes that run from 8:15-3:10. Parents may choose to send children for half days, but will pay the same cost of the full day program. If you choose to pay the total cost up front, you will receive a 5% discount. This is due on August 30, 2024.

## K-8 Tuition Policy & Fee Schedule 2024-25

Families registered and participating in any Catholic parish are eligible for the Catholic tuition rate. The actual cost to educate each student for the 2024-2025 school is **\$7,902**.

If you choose to pay the total tuition cost in one payment, you will receive a 5% discount. This is due on August 30, 2024.

**8<sup>th</sup> Grade Only:** Graduation Fee **\$30 per student**

This will be deposited into their class account. It will help with scholarships, caps and gowns, parties, gifts, and more.

## **FACTS Family Portal**

New families will set up a FACTS account by following the step by step instructions on the [FACTS Family Portal instructions at this link](#). Each family will have an online agreement for paying tuition. An agreement confirmation will detail the terms & conditions, payment instructions, and other important information. A \$10 late fee will be incurred for past due payments. If a payment is returned, a \$30 FACTS Returned Payment Fee will be assessed and shown on your statement. Student grades, nurse information, and other important information will be housed in the FACTS system.

## **Tuition Assistance**

Tuition assistance is funded by Angel Fund Donations and is made available based on the amount of money in these particular accounts; funds are limited. Tuition assistance is available for Sacred Heart/Our Lady of the Rosary families only who need additional resources. You may apply for Tuition assistance through [Facts Management at this link](#). There is a \$40 application fee. When your Tuition assistance form is approved, your FACTS account will be credited for this fee. Tuition assistance applications are due no later than May 1, 2023. Late applications will not be accepted.

## **PALS**

The PALS Program (Parents Assist Learning in Schools) is responsible for educating, registering and monitoring volunteers for the various activities in which volunteers are needed. The PALS program is a parent/guardian involvement program which requires a service commitment. Each family will commit to **twenty (20) hours**, worth of service to Sacred Heart Catholic School, to be fulfilled during the year. Each PAL hour is equal to \$20.00. At the fiscal year end (June 30), PALS hours will be totaled, and any unearned hours will be assessed at \$20.00 per hour and posted to your school account. If a family chooses to waive their PALS hour obligation, they may pay \$400.00 at registration to fulfill this commitment. PALS hours are documented on the main FACTS family portal page.

## **SCRIP/Raiseright**

The Sacred Heart SCRIP Program was founded in 1997 as a supplemental fundraising activity for Sacred Heart Catholic School. The SCRIP program allows Sacred Heart Catholic School to receive a portion of the purchase price of gift certificates from hundreds of national participating retailers. The SCRIP program was implemented to reduce the necessity of Sacred Heart students having to engage in additional fundraising activities. The minimum SCRIP purchase commitment will be \$1000 for the current school year.

If a family chooses to waive their SCRIP commitment they may pay \$300 at registration to fulfill this obligation. Failure for families to meet the minimum SCRIP requirement will result in the family being invoiced for the remaining amount (\$.30 per SCRIP dollar remaining).

## **Parish Agreement**

Any family who is a member of a Diocese of Boise Catholic Parish and is receiving the Catholic SHC/OLR or Catholic non-parish tuition rate, must fill out the parish agreement form. This form must be signed by your parish office and is required in order to qualify for those discounted rates. Parish agreement forms are due June 30, 2024.
